The Graham County Board of Commissioners met Thursday, October 18, 2018 at 2:00 p.m. for a continued meeting from the regular meeting held on Tuesday, October 16, 2018 in the Graham County Community Building located at 196 Knight Street Robbinsville NC. Board present was: Commissioner Connie Orr, Dale Wiggins and Raymond Williams. Board absent was: Commissioner Keith Eller and Jacob Nelms.

- 1. Commissioner Wiggins called the continued meeting to order.
- 2. Commissioner Wiggins asks for approval of the agenda. Commissioner Orr made the motion to approve the agenda. Commissioner Williams seconded this motion. Vote unanimous.
- 3. Commissioner Wiggins asks for comments from the evaluation of the DSS Facility. Commissioner Orr stated that we needed to provide cabinets for storage into the areas that a need was present and after installation relook and go from there. Commissioner Orr stated that the ability to pass in the halls is limited and this needs immediate attention. Commissioner Orr stated that we needed a chalkboard in the area where children are meeting with their families, a 4x8 sheet. Commissioner Wiggins stated that we could consider installing the coated finish for chalkboard on the walls and the kids can use chalkboard paints that wash off and this would keep us from putting holes in the walls. Manager Garland stated that Melissa Blevins had contacted her about the boxes in the floors and felt that this is a fall hazard and with the Department of Labor coming to the county we needed to address this.
- 4. Commissioner Williams stated that a water dispenser needed to be put in the front lobby of DSS due to the kids running in and out of the door that has be buzzed in and out by the receptionist. Clerk Crisp stated that we have an extra one through our water supply company. Commissioner Wiggins stated that we need to get one with the bottles so that we do not have to drill in the walls to get the water lines. Manager Garland will look into this.
- 5. Manager Garland had the completed Resolution to the County Manager of delegation of duties concerning appointed officials. Commissioner Williams made the motion to approve the resolution. Commissioner Orr seconded this motion. Vote unanimous.
- 6. Commissioner Wiggins stated that we would need to go into closed session to discuss the names of the CDBG recipients. Commissioner Orr made the motion to go into closed session under G.S. 143-318.11(a) (1) (6) for privileged or confidential information and personnel. Commissioner Williams seconded this motion. Vote unanimous.
- 7. Commissioner Orr made the motion to go back into open session. Commissioner Williams seconded this motion. Vote unanimous.
- 8. Commissioner Orr made the motion to continue the meeting until Monday, October 22, 2018 for the CDBG Public Hearing. Commissioner Williams seconded this motion. Vote unanimous.
